# VA Office of Tribal Government Relations (OTGR)

#### **Established office in January 2011**

- ➤ In response to President Clinton's Executive Order 13175 and President Obama's memorandum on Tribal Consultation dated November 5, 2009
- Recognizes unique Government-to-Government relationship with tribes
- ➤ 5 FTEE Director, Program Analyst, 4 Regional Specialists

#### VA's Tribal Consultation Policy completed on February 2011


- First VA consultations occurred in 2012
- Most recent in August 2018

## **OTGR Specialists hired August/September 2011**

- Responsible for managing a portfolio of relationships with tribal governments within a specific region
- Serve as a resource to tribal governments for VA services

# **American Indian/Alaska Native Service Members and Veterans**

- American Indian and Alaska Native Veterans have played a vital role in the U.S. military for over 200 years.
- Native Americans serve at a higher rate when compared to other races
- Approximately 134,000 Veterans, comprising of 0.7% of almost 19 million Veterans – this is important to note because there is less than 1.0% AIAN race





## Challenges Facing American Indian/Alaska Native Veterans

- Three times more highly rural than non-Native Veterans
- Younger as a cohort than all other Service Members and Veterans
- More female Veterans serve than non-Native
- Lower Income levels and educational levels
- ➤ Higher degree of combat service more service connected Veterans than other non-Native counterparts



## VA OTGR – 3 MAIN GOALS

#### **Goal 1: Implement VA's Tribal Consultation Policy**

- > Top priorities for serving Veterans in Indian Country
- > Accreditation of Tribal Veterans Service Offices
- ➤ A proposed consolidation of non-VA care into a more standardized system under the Choice Act




- Through utilization of GI Bill benefits for education

- Expand knowledge and use of the Native American Direct Loan Program for VA home loans on trust lands





## OTGR Goal 2: Facilitate Increased Access to Health Care & Benefits

➤ OTGR works closely with tribes to implement the VA, Indian Health Service and Tribal Health Programs Reimbursement Agreements. VA reimburses IHS and THP programs for direct care services provided to eligible American Indians and Alaska Native Veterans. These agreements increase access to care for American Indians and Alaska Native Veterans nationwide, in particular those highly rural Veterans living within Indian Country.
